AGREEMENT ON SCIENTIFIC AND EDUCATIONAL COOPERATION

Prologue

Article 1

This agreement aims to enhance cooperation in the field of education, science, research and cultural relations between the Law Institute of Vasyl Stefanyk Precarpathian National University in Ivano-Frankivsk and the Faculty of Law, Trnava University.

Subject matter of the Agreement

Article 2

Cooperation between the Law Institute of Vasyl Stefanyk Precarpathian National University in Ivano-Frankivsk and Faculty of Law, Trnava University (hereinafter referred to as "Institute and faculty") will be conducted in the following areas:

- a) the organization of scientific cooperation,
- b) implementation of joint scientific and research projects,
- c) exchange of researchers and educators,
- d) exchange of students in bachelor, master's and doctoral program,
- e) exchange of professional literature, textbooks and other publications,
- f) mutual acquaintance with the activities of student organizations,
- g) mutual acquaintance with the activities of Institute and faculty.

Scientific cooperation

Article 3

- (1) Scientific cooperation between Institute and faculty is realized mainly by organizing joint scientific meetings, conferences and seminars and carrying out joint scientific and research projects (including EU grants and Visegrad grants).
- (2) Scientific cooperation between Institute and faculty includes also cooperation in the accredited qualifications of doctoral program that Institute or faculty offers.
- (3) Scientific cooperation will cover Joint research in the field of Private Law (Commercial Law, Corporate Law, Contract Law), Procedural Law and other branches of Law (Criminal Law, Environmental Law etc).

Educational cooperation

Article 4

- (1) Educational cooperation between Institute and faculty is realized mainly through the exchange of researchers and educators of Institute and faculty for the purpose of lecture or study visits.
- (2) Exchange of researchers and educators can be performed also on the basis of the LLP / ERASMUS programs. Detailed conditions for the implementation of this program will be stated in a special agreement between Law Institute and the Faculty of Law.
- (3) Exchange of educators Institute and faculty are contingent upon an approval of educator's work or study program by the host Institute/Faculty.
- (4) Work or study program is validated by the dean of a sending Institute/Faculty.
- (5) Details of the exchange of educators, especially the duration of the exchange stay will be agreed in advance with the partner organizational unit (department, institute) of host Institute/Faculty.
- (6) Sending Institute/Faculty covers the expenses associated with educator's stay (travel and accommodation costs).
- (7) Institute or faculty informs each other of exchanging stays of their educators planned for the next academic year, until the end of February of the previous calendar year.

Student mobility

Article 5

- (1) Institute and faculty cooperate in mutual exchanging of students in bachelor, master's and doctoral program realized by the Institute or Faculty.
- (2) Exchange of Institute and faculty students is based on an individual discussion of particular proposals for the purpose of student mobility realization.
- (3) Student can submit a written request to the dean of Institute or faculty, where he is enrolled on studies, to discuss the proposal of student mobility with the dean of a host Institute or faculty.
- (4) Student mobility between Institute and faculty can be performed also on the basis of the LLP / ERASMUS programs. Detailed conditions for the implementation of this program will be stated in a specific agreement between Law Institute and Faculty of Law.

Other forms of cooperation

Article 6

- (1) Institute and faculty cooperate in exchanging of professional literature, textbooks and other publications.
- (2) Institute and faculty cooperate within their publishing activities, in particular by publishing joint technical and scientific publications, textbooks and reviews.

Article 7

- (1) Institute and faculty should secure a suitable platform for mutual cooperation between student organizations operating at the faculties.
- (2) Institute and faculty collaborate in organizing joint student conferences and simulated lawsuits.

Article 8

Institute and faculty provide and shares information about scientific and student life one to each other.

Final provisions

Article 9

- (1) The Agreement is concluded for an indefinite period.

- 2) Agreement may be terminated in writing by either party. The agreement repeals in the six month notice period which commences on the first day of the month following after the month in which the written notice was delivered to the other party.

Article 10

This Agreement enters into force after the signature by both parties.

Article 11

Agreement is elaborated in four originals in English language.
